

(herein referred to as grantee, whether one or more), the following described real estate, situated in County, Alabama, to-wit: Shelby

Commence at the Northwest corner of Section 13, Township 21 South, Range 1 East; thence proceed in an Easterly direction along the North boundary line of said Section 13 for a distance of 2124.84 feet to a point, being a point on the centerline of a 60 foot dedicaced R.O.W. within Sunrise Cove Subdivision, recorded in Map Book 5, Page 31, Office of Probate, Shelby County, Columbiana, Alabama; thence turn an angle of 86 deg. 25 min. to the right and proceed for a distance of 150.00 feet to a point; thence turn an angle of 42 deg. 06 min. to the right and proceed for a distance of 100.00 feet to a point; thence turn an angle of 90 deg. to the left and proceed for a distance of 30.00 feet to a point, being the Northwest corner of Lot 25 of Dabove mentioned Subdivision; thence turn an angle of 109 deg. 17 min. 29 sec. to the right and proceed for a distance of 207.66 feet to a point; thence gturn an angle of 19 deg. 30 min. 30 sec. to the left and proceed for a \leq distance of 153.4 feet to a point; thence turn an angle of 105 deg. 31 min. 46 sec. to the right and proceed for a distance of 193.96 feet to a point; thence turn an angle of 79 deg. 25 mir. 50 sec. to the right and proceed for That distance of 99.58 feet to a point; thence turn an angle of 84 deg. 18 min. $_{\infty}54$ sec. to the right and proceed for a distance of 49.28 feet to a point, Ssaid point being the point of beginning of the property herein conveyed; thence continue along last described course a distance of 129 feet to a point on the Northwest right-of-way of Sunrise Circle; thence run in a Northdirection along the Northwest right-of-way of said Sunrise Circle a distance of 227 feet to a point; thence run in a Westerly direction a distance of 200 feet to an iron stake; thence run in a Southwesterly direction a distanc of 156 feet to the point of beginning.
