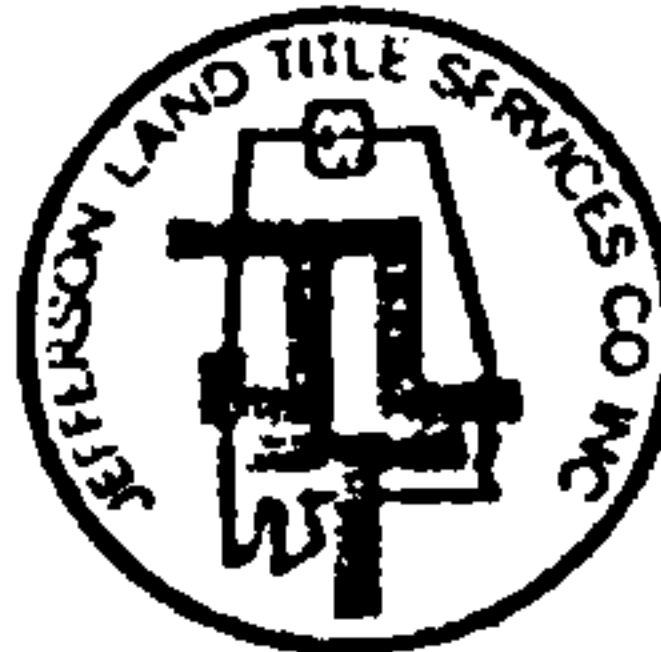

in hand paid to the undersigned, the receipt whereof is hereby acknowledged,  
the undersigned hereby releases, quitclaims, grants, sells, and conveys to  
Charles W. Holsomback, Jeffrey Wayne Holsomback, Joey William Holsomback,  
and Jimmy Wade Holsomback  
(hereinafter called Grantee), all our right, title, interest, and claim in or  
to the following described real estate, situated in Shelby

County, Alabama, to-wit:  
Commence at the intersection of the South line of the N $\frac{1}{2}$  of the NE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of  
Section 11, Township 22 South, Range 4 West, with the West right-of-way line of County  
Highway No. 10; thence run West along said South boundary line a distance of 330 feet
