FORECLOSURE DEED

WHEREAS, The First National Bank of Birmingham, a national banking association, (hereinafter sometimes called "Bank") was on September 18, 1981, the owner and holder of the following described mortgage and the debt secured thereby: mortgage executed by Swalley Construction Company, Inc., (hereinafter sometimes called "Mortgagor,") to the Bank on August 1, 1978, which mortgage is recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Real Volume 382, page 99 (hereinafter called "Mortgage"); and

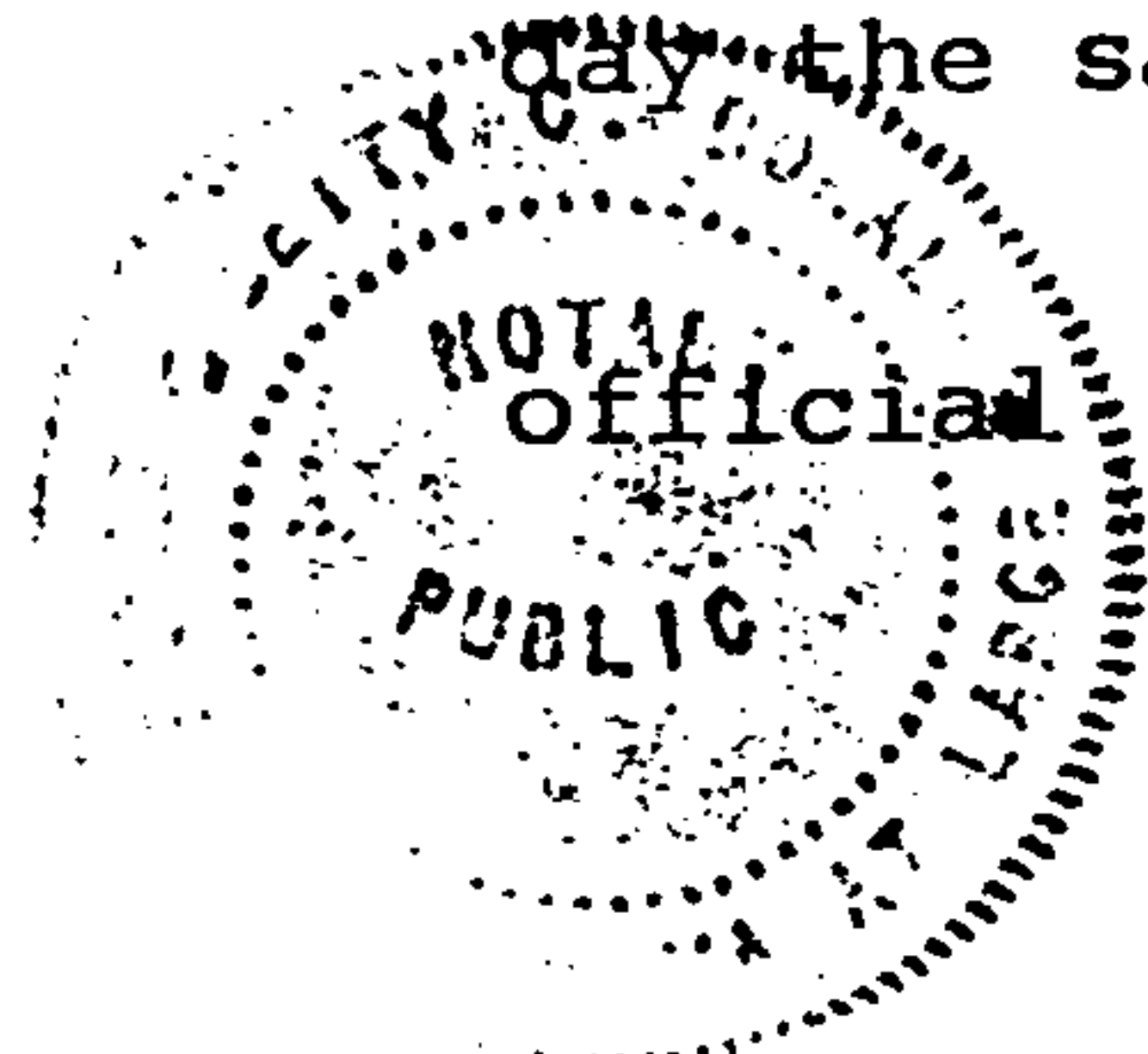
