FORECLOSURE DEED OF CORRECTION

This indenture made and entered into by and between Homestead Construction Company, Party of the First Part, and First Alabama Bank of Birmingham, a corporation, Party of the Second Part,

Witnesseth:

That, WHEREAS, said Party of the First Part did under date of the 1st day of June, 1979, execute a mortgage to First Alabama Bank of Birmingham, a corporation, on the hereinafter described property which mortgage is duly recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Book 392, page 600, Record of Mortgages, and;

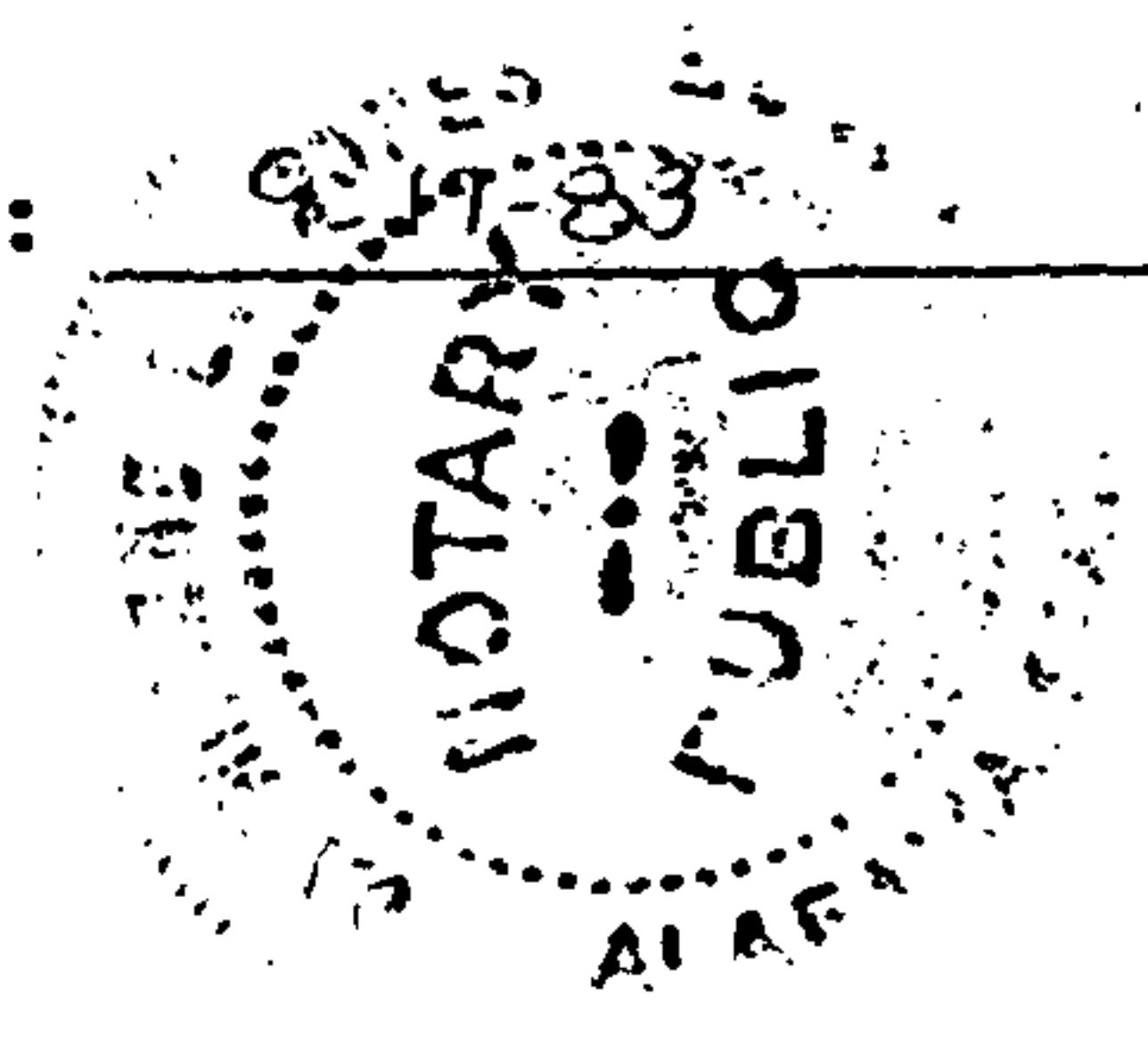
