Before me, the undersigned, personally appeared JOHNNY PATTERSON, who, after first being duly sworn, deposes and says the following:

My name is Johnny Patterson and I am over the age of twenty-one (21) years, and a resident citizen of Shelby County, Alabama. My wife and I are in the process of executing a mortgage to the Federal Land Bank and mortgage the following described property, to-wit:

The NW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 12, Township 22 South, Range 3 West. Part of the SW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 12, Township 22 South, Range 3 West, described as follows: Beginning at the Southwest corner of said forty and run North 2 degrees 30 minutes West 1320 feet; thence run North 86 degrees 25 minutes East 359.8 feet to point of beginning; from said point of beginning run North 86 degrees 25 minutes East 292 feet to the North line of Columbiana-Montevallo public road; thence with North side of said road South 67 degrees 30 minutes West 120 feet; thence continue on North side of said road South 58 degrees 20 minutes West 108 feet; thence North 46 degrees 40 minutes West 122 feet to point of beginning. ALSO part of SW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 12, Township 22 South, Range 3 West, described as follows: Begin at the Northwest corner of said forty acres and run North 86 degrees 25 minutes East 359.8 feet; thence run South 46 degrees 40 minutes East 122 feet to center of Montevallo-Columbiana road; thence along center of said road South 60 degrees West 274 feet; thence run in a Northwesterly direction in a direct line to the point of beginning.
