DECLARATION OF VACATION OF STREET

SHELBY COUNTY

WHEREAS, the undersigned, CALERA BAPTIST CHURCH, INC., a corporation, is the owner of all the property abutting the hereinafter described portion of an alley running North and South through Block 3, according to Dunstan's Map of the Town of Calera, Alabama, which said map shows the location of the alley hereinafter described;

WHEREAS, CALERA BAPTIST CHURCH, INC., a corporation, is desirous of vacating a portion of said alley, as same appears on said map, and the centerline of said portion of said alley is described as follows:

From the Northern boundary of Alabama State Highway No. 25, also designated as Eighteenth Avenue, run North along the centerline of an alley 181.31 feet, said alley running North and South between Lots 4, 5, 6 and 7, 8, 9 of Block 3 according to Dunstan's Map of the Town of Calera, Alabama, located in Section 21, Township 22 South, Range 2 West, Shelby County, Alabama.

NOW, THEREFORE, the undersigned CALERA BAPTIST CHURCH, INC., a corporation, does hereby declare that portion of said alley described herein to be vacated; and the following portion of said streets shown thereon is hereby vacated:

The undersigned CALERA BAPTIST CHURCH, INC., a corporation, does, hereby pursuant to and in accordance with the provisions of Section 23-4-20, Code of Alabama, 1975, execute this written declaration of vacation of said portion of said alley, the same being within the city limits of the City of Calera, and does pray and
