

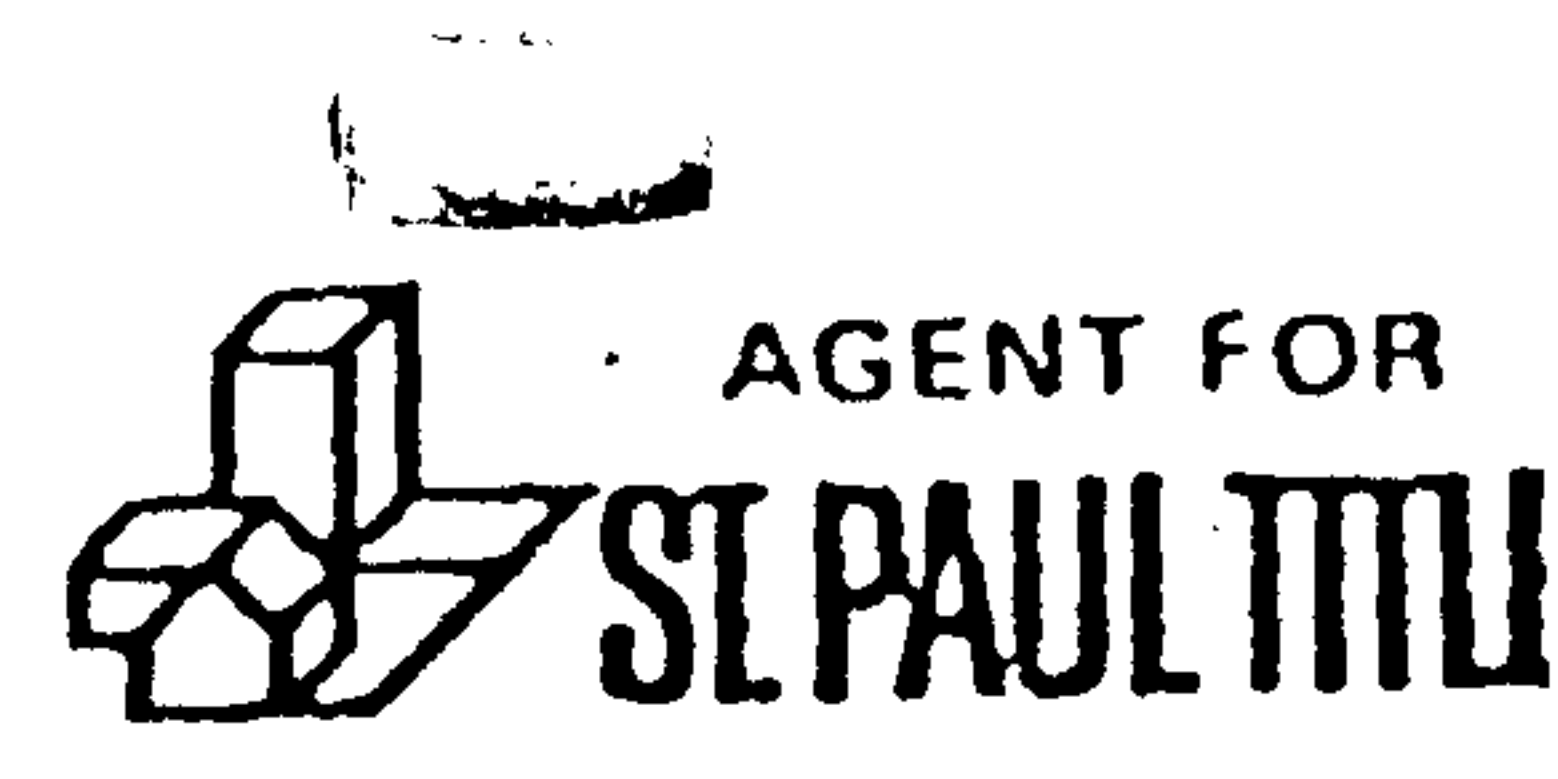

WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR - CORRECTIVE DEED

STATE OF ALABAMA
SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Thirteen Thousand Five Hundred and no/100 (\$13,500.00) DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

James N. Sangilantonio and wife, Beverly K. Sangilantonio

(herein referred to as grantors) do grant, bargain, sell and convey unto

Don M. Ortino, Jr. and Frances R. Ortino

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 7, Block 2, according to the survey of Mountain View Estates as recorded in Map Book 4, Page 19 in the Probate Office of Shelby County, Alabama.

Mineral and mining rights excepted.

Subject to easements and restrictions of record.

For and in consideration of Thirteen Thousand Five Hundred Dollars (\$13,500.00) cash in hand paid, the receipt of which is hereby acknowledged, and other good and valuable consideration, a part of which is the assumption of one certain Mortgage dated May 2, 1978 and filed for record May 2, 1978 in the Office of the Judge of Probate of Shelby County, Alabama, in Mortgage Book 377, Page 711, and note of even date thereby secured, in the original principal amount of \$44,500.00, payable to Molton, Allen and Williams, Inc. which debt the Grantee herein assumes and agrees to pay as part part payment of the purchase price.

The Grantee further hereby assumes the obligations of James N. Sangilantonio and wife, Beverly K. Sangilantonio under the terms of the instruments creating the loan to indemnify the Veterans Administration to the extent of any claim arising from the guaranty or insurance of the indebtedness above mentioned.

TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
