

Commence at the Southeast corner of SE½ of NW½ of Section 34, Township 19, Range 2 East and run South 87 deg. 30 min. West 229.83 feet to the Easterly right-of-way line of U. S. Highway No. 280 (also known as Ala. Highway 91) and run North 56 deg. 20 min. West, along said right-of-way line 1750 feet to an iron pin to the point of beginning of the land herein conveyed, which point of beginning is the Westmost corner of a lot known as the Abbott lot; thence North 33 deg. 40 min.
