TURNER and wife, BETTY JEAN TURNER; WILLIAM I.

TURNER and wife, SARA JO TURNER; LLOYD M. TURNER, an unmarried man; RUBY J. CLINKSCALES and husband, E. M. CLINKSCALES; EMOJENE BARNES and husband, JOSEPH D. BARNES; and BILLY BEATTY, an unmarried man (herein referred to as grantors), do grant, bargain, sell and convey unto EMOJENE BARNES and JOSEPH D.
