CLINKSCALES; EMOJENE BARNES and husband, JOSEPH D. BARNES; and BILLY BEATTY, an unmarried man (herein referred to as grantors), do grant, bargain, sell and convey unto EMOJENE BARNES and JOSEPH D. ALSO an easement for ingress and egress described as follows: Commence at the NW corner of the NE% of the NE% of Section 27.
