

CLINKSCALES; and BILL BEATTY, an unmarried man (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto HAROLD JEROME TURNER, (herein referred to as grantee, whether one or more), the following described real estate, situated in SHELBY County, Alabama, to-wit:
