

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

(whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, we HAZEL CONNELL CARDEN, unmarried;  
MARGIE ALLEANE BARNES, unmarried; LINDA FAYE DOYLE and husband,  
ROBERT DOYLE; JANET GAYLE O'LINGER and husband, DENNIS O'LINGER;  
JERRY WAYNE CONNELL, unmarried; and THELMA CHRISTINE CONNELL, unmarried (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto HOWARD CONNELL  
(herein referred to as grantee, whether one or more), all our undivided interest in and to the following described real estate, situated in SHELBY County, Alabama, to-wit:

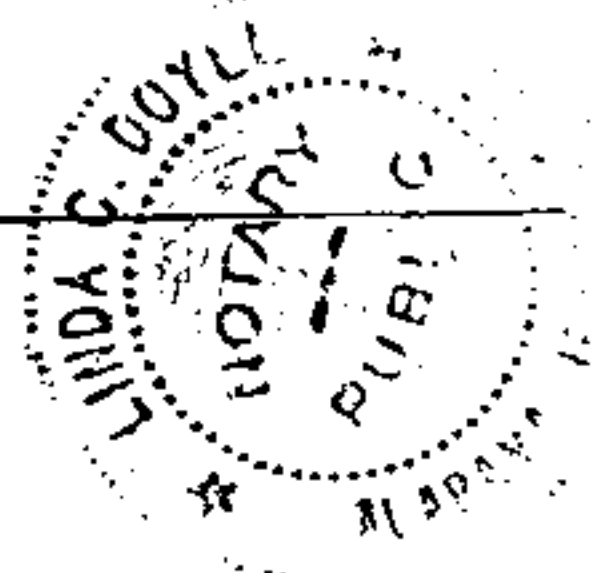
