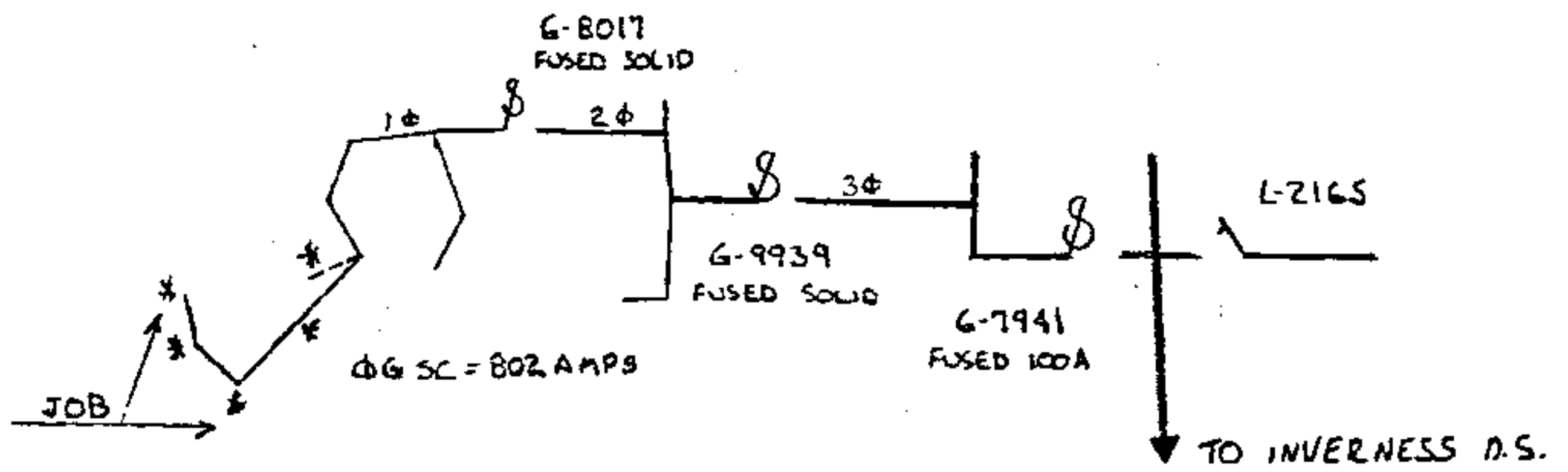

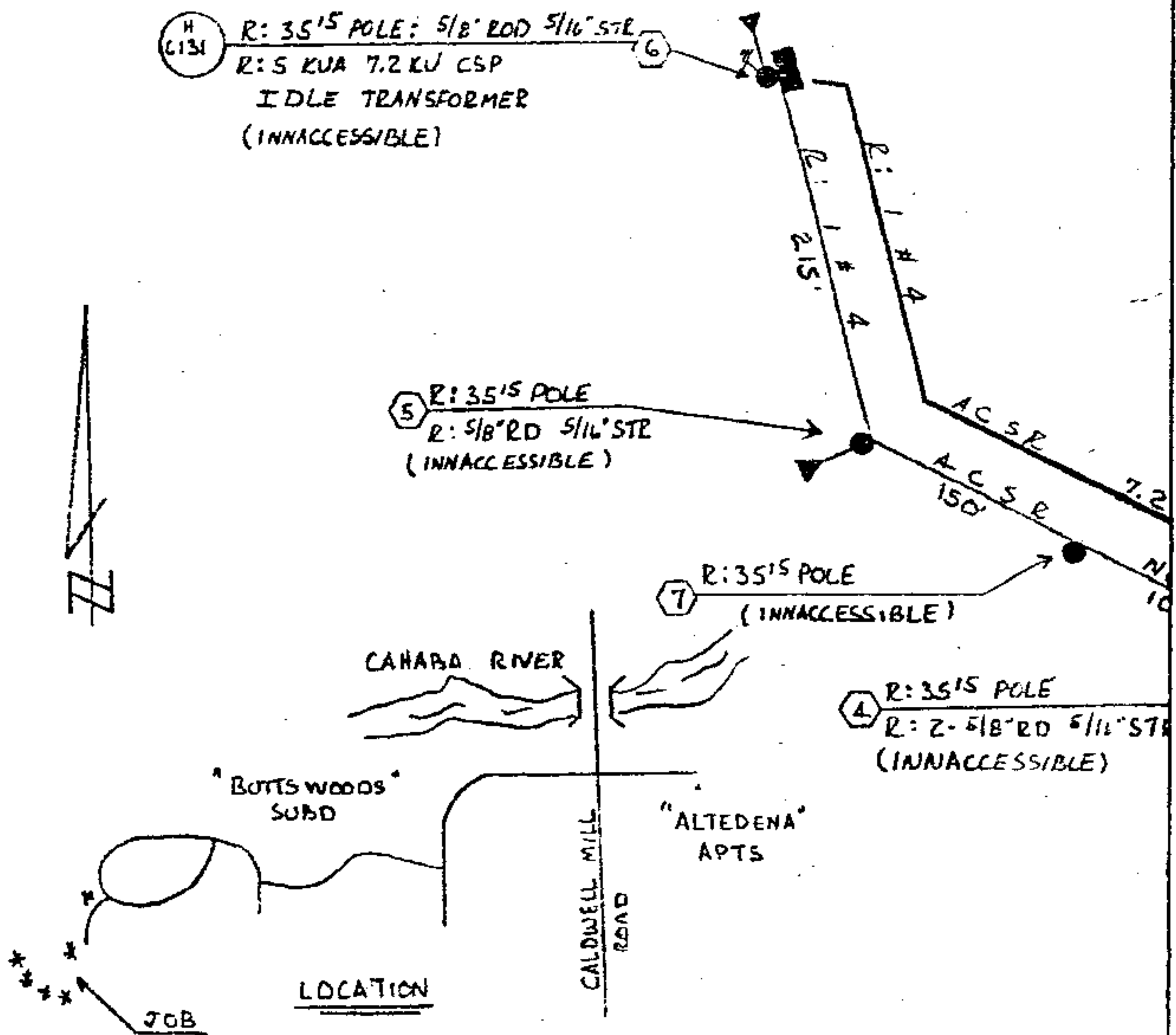

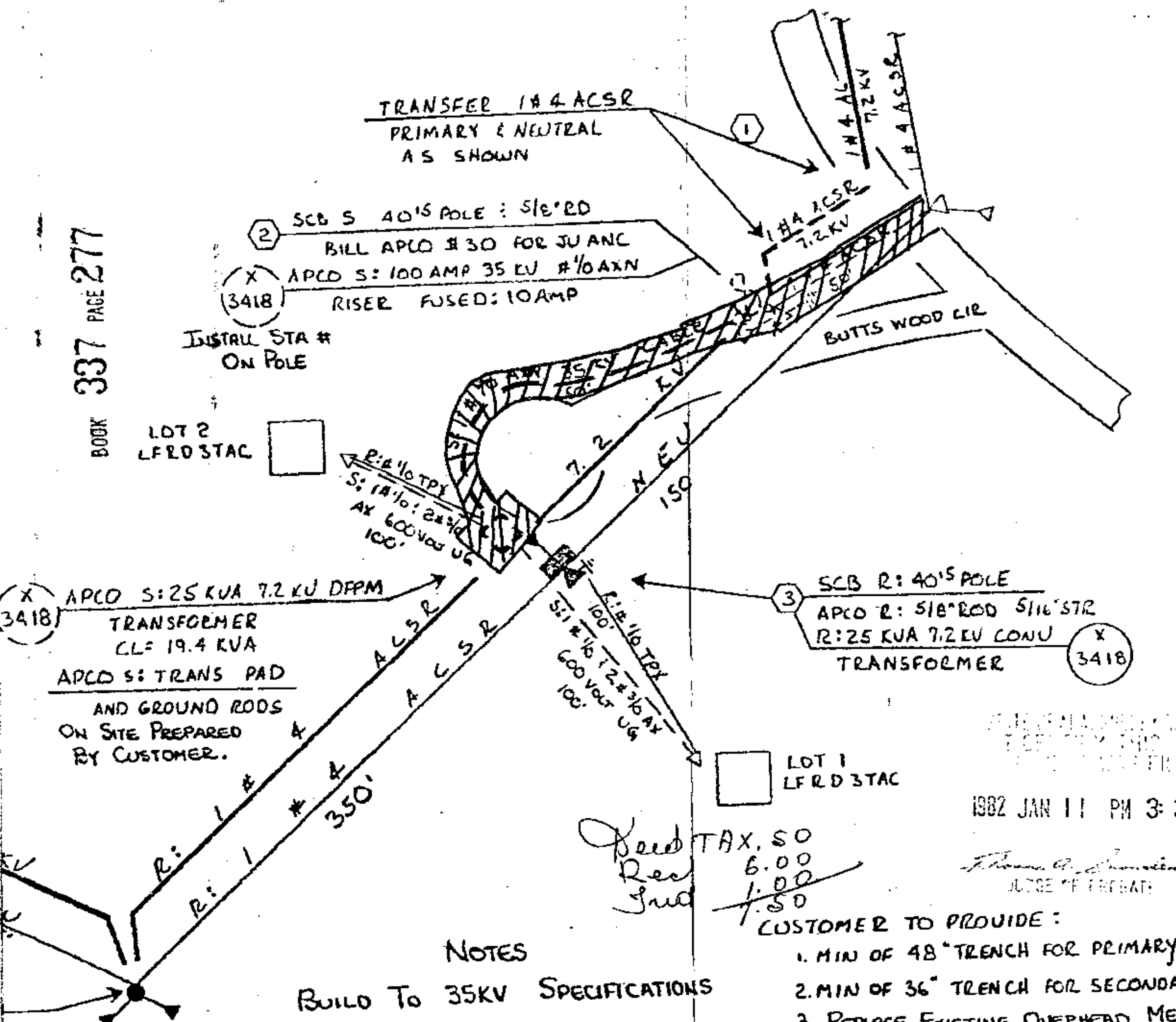


PLACE HOT LINE TAG AT G-7941
