ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ACWI Systems, Incorporated.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

For all lawful purposes, and specifically, for the preparation and sale of computer programs and management of collection services.

FOURTH: The aggregate number of shares which the corporation shall have the authority to issue is 100 shares of common stock having a par value of \$1.00 per share.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as provided in the Bylaws adopted or to be adopted by simple majority vote of the issued and outstanding shares of the corporation.

SIXTH: The address of the initial registered office of the corporation is Room 202-A Jessup Building, Alabaster, (Shelby County) Alabama 35007. The initial registered agent at such address is William P. Wildes.

SEVENTH: The number of directors constituting the initial Board of Directors of the corporation are three (3), and the names and addresses of the persons who are to serve as directors and officers of the corporation until the first annual meeting of shareholders or until their successors are elected and shall qualify are.
