GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That I, Ronald M. Lawyer, ✓

and lawful attorney to manage and conduct all my business

or property, as fully and effectually to all intents and purposes
as I might or could do in my own proper person if personally
present and acting for myself.

The power of my said attorney shall include (without
limitation of the aforementioned general power) the power to

due or to become due to me; to deposit in my name in any
bank or banks any and all monies collected or received by or
for me; to have access to any safety deposit box held in my
name in any bank or trust company, and to the contents of
any such box; to pay any and all bills, accounts, claims and
demands now or hereafter payable by me; to draw checks or
drafts upon any and all bank accounts or deposits belonging
to me; to prepare and sign tax returns and other instruments
required by any governmental authority; to sell, buy, convey,
mortgage, lease, invest and reinvest my said property; to
make, execute and acknowledge any and all contracts, orders,
leases, bills of sale, deeds and instruments required in
such management of my affairs. The specifically enumerated
powers in this paragraph are in aid and exemplification of
the full, complete and general power herein granted and are
not in limitation or definition thereof, and I hereby ratify
and confirm whatsoever my said attorney shall lawfully do or
cause to be done by authority of this instrument.
