

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Ten and no/one-hundredths (\$10.00) dollars, and other good and valuable consideration to the undersigned Federal Home Builders, Inc., an Alabama corporation (herein referred to as Grantor), in hand paid by F P No. 6, Ltd., an Alabama limited partnership (herein referred to as Grantee), the receipt of which is hereby acknowledged, the said Grantor does by these presents grant, bargain, sell, and convey unto said Grantee the following described real estate situated in Shelby County, Alabama, to-wit:
