KNOW ALL MEN BY THESE PRESENTS, That the undersigned Ralph E. Sorrell and wife, Bonnie R. Sorrell for and in consideration of the sum of Seven Thousand Five Hundred and No/100-----Dollars (\$7,500.00) to μ_5 in hand paid by Alabama Power Company, a corporation, the receipt whereof is hereby acknowledged, we hereby grant to said Alabama Power Company, its successors and assigns, the right to cut and trim and to keep cut and trimmed, and remove any timber within fifteen (15) feet of the strip of right of way described hereinafter which in falling would come within five (5) Det of the electric transmission lines of said Alabama Power Company, its successors and assigns, to be constructed on such strip adjacent to grantors property in the Northwest Quarter of the Northwest Quarter (NW4 of NW4) of Section 24, Township 20 South, Range 3 West, Shelby County, Alabama.

Said strip of right of way being more particularly described as follows:

To reach the point of beginning of said strip of right of way, commence at the Northwest corner of Section 24, Township 20 South, Range 3 West; thence run East along the North boundary line of said Section 24 a distance of 964.3 feet to a point; thence turn an angle to the right of 77 degrees 54 minutes and run South 09 degrees 50 minutes East a distance of 17 feet, more or less, to a point, such point being the point of beginning of the strip of right of way herein described; therefrom, said strip of right of way is ten (10) feet in width and lies five (5) feet on each side of a center line and the continuations thereof which begins at Such point of beginning and runs South 09 degrees 50 minutes East a distance of 292.3 feet to a point; thence turn an angle to the right of 03 degrees 52 minutes and run South 05 degrees 58 minutes East a distance of 87.2 feet to a point, such point being called Point A for reference hereinafter; thence continue to run South 05 degrees 58 minutes East a distance of 281.4 feet to a point; thence turn an angle to the right of 36 degrees 53 minutes and run South 30 degrees 55 minutes West a distance of 4.6 feet to a point, such point being called Point B for reference hereinafter and also being the point of ending of said strip of right of way.
