and Lessor hereby grants, lets, and leases unto Lessee for the sole and only purpose of investigating, exploring, prospecting, drilling and operating for and producing only liquid and gaseous petroleum hydrocarbons produced from a conventional oil and gas well, laying pipelines, building tanks, power stations, roads, communication lines and maintaining such works, to save and take care of and transport said products on and from the land so described, subject to all terms, provisions, and conditions specified in said Oil and Gas Lease, and also subject to termination as specified in said Oil and Gas Lease with the said Primary Terms not to exceed Five (5) years from the date hereof, and for the consideration expressed.
