The NW¼ of the NE¼ of Section 4, Township 24, Range 13 East, Shelby County, Alabama.

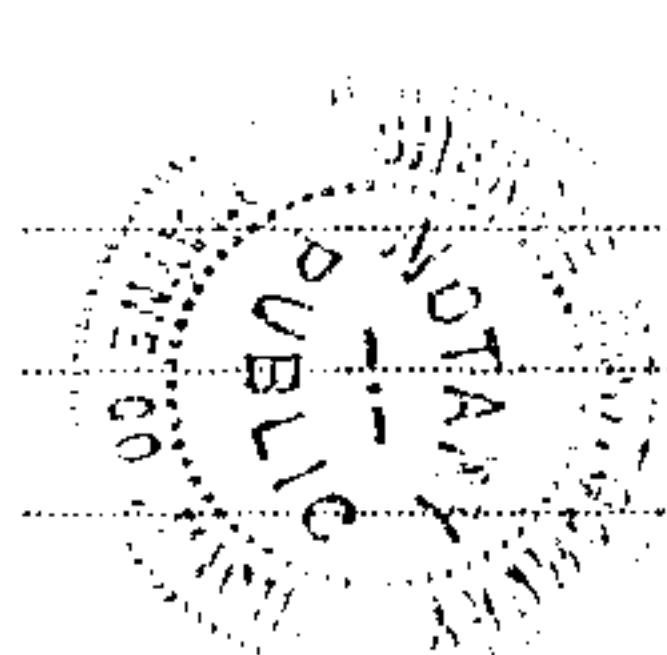
