ARTICLES OF INCORPORATION
OF

Aqua - Ag., Inc.

A CLOSE CORPORATION

The undersigned, acting as incorporators of a corporation under the Alabama Business Corporation Act., adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is:

Aqua-Ag., Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: (a) To engage in the general sales business; (b) To engage in the business of selling, at wholesale or retail, and distribution of commercial food and feed grains; and (c) Such other, further and general purposes which are set out in the Code of Alabama.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 110 shares of common, of the par value of Ten Dollars per share, constituting a total authorized capital of One Thousand Ten Dollars (\$1,010.00) and consisting of such one class only.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are: The business shall be conducted by the express authority of the shareholders, Kenneth J. Neal & Alan H. Belcher, and business shall be conducted in a normal, businesslike and corporate manner.

SIXTH: The address of the initial registered office of the corporation is 1130 Montgomery Highway, Alabaster, Alabama, 35007, and the name of its initial registered agent at such address is Kenneth J. Neal.


