Know all men by these Presents; That the undersigned, Mrs. Agnes Crenshaw, W.E. Linholm and his wife Mrs. Mae Linholm, D.R. Linholm and his wife Mauden Linholm, Annie Linholm an unmarried woman, Julia Linholm an unmarried woman and Annie Linholm guardian of Julia Linholm, grantors; for and in consideration of One dollar to each of said grantors, in hand paid by John Linholm, the receipt whereof is hereby acknowledged, and the further consideration of the execution of a deed by the said John Linholm to each of said grantors bearing even date with this instrument, and conveying certain lands therein described, do hereby grant bargain sell and convey to the said John Linholm, surface right only, in and to the following described lands, to-wit:

All that part of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 15, Twp. 22, Range 4 West, situated in Shelby County, Alabama, and bounded and described as follows, to-wit: Commencing at the South East corner of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 15, Township 22, Range 4, West; and running thence north along and with the eastern boundary line of said named subdivision a distance of $146\frac{2}{3}$ yards to a stake; thence west on a straight direct line to a point on the western boundary line of said subdivision, $146\frac{2}{3}$ yards north of the south west corner of said subdivision; thence south along and with the western boundary thereof to the south west corner of said subdivision; thence east along and with the southern boundary line of said subdivision a distance of 440 yards to the south east corner thereof, the point of beginning.

Said block or tract herein conveyed and described being 440 yards in length running east and west, and $146\frac{2}{3}$ yards in width running north and south, and embracing $64.553\frac{1}{3}$ square yards in area.
