Assignment of Rents; Appointment of Receiver; Lender in Possession. As additional security hereunder, Borrower bareby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 18 rereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable. Upon acceleration under paragraph 18 hereof or abandonment of the Property, Lender, in person, by agent or by significantly appointed receiver, shall be entitled to enter upon, take possession of and manage the Property and to collect The rents of the Property including those past due. All rents collected by Lender or the receiver shall be applied first to payment of the costs of management of the Property and collection of rents, including, but not limited to, receiver's fees, (N) premiums on receiver's bonds and reasonable attorney's fees, and then to the sums secured by this Mortgage. Lender and the receiver shall be liable to account for only those rents actually received. 21. Future Advances. Upon request of Borrower, Lender, at Lender's option prior to release of this Mortgage, may Esmake Future Advances to Borrower. Such Future Advances, with interest thereon, shall be secured by this Mortgage when Esevidenced by promissory notes stating that said notes are secured hereby. 22. Release. Upon payment of all sums secured by this Mortgage, this Mortgage shall become null and void, and Lender shall release this Mortgage, without charge to Borrower. Borrower shall pay all costs of recordation, if any. 23. Waiver of Homestead, Dower and Curtesy. Borrower hereby waives all rights of homestead exemption in the Property and relinquishes all right of dower and curtesy in the Property.
