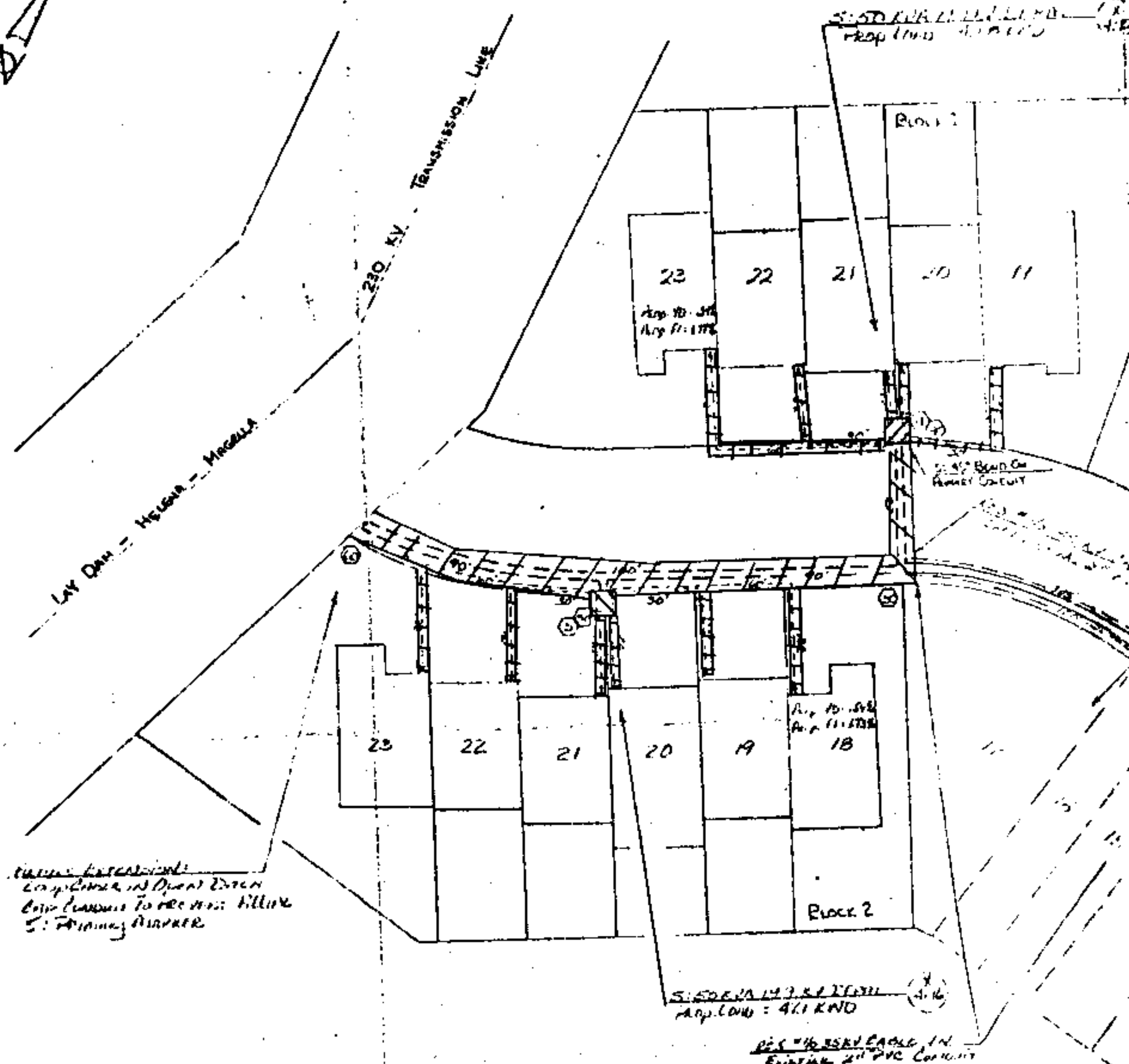

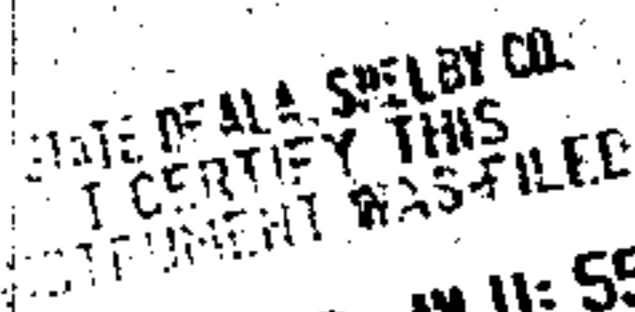


EXISTING INTERSECTION
