DISSOLUTIONMENT OF LIMITED PARTNERSHIP

THIS AGREEMENT entered into on the 11 day of June, 1982, between Frank Haynie (hereinafter referred to as "General Partner") and Joe Mizerany, D. W. Huey and J. C. Miller (hereinafter referred to as "limited Partners"), the said parties agreeing as follows:

1. That the Limited Partnership known as "Haynie Ltd." was formed on July 13, 1979 and that its only conduct of business has been ownership of certain real property situated in Shelby County, Alabama, to-wit:

Beginning at the Southeast Corner of the Northeast 1/4 of the Northwest Quarter of the Southwest Quarter of Section 14, Township 19 South, Range 2 West, and run Northerly along the East line of said Quarter-Quarter-Quarter Section, 530.70 feet; thence turn left an angle of 88 degrees 19 minutes 30 seconds and run westerly, 660.78 feet to the West line of said Quarter-Quarter-Quarter Section; thence turn left an angle of 91 degrees 36 minutes 30 seconds and run Southerly along said West line 530.00 feet; thence turn left an angle of 88 degrees 20 minutes 30 seconds and run Easterly 661.41 feet to the point of beginning, containing 8.0 acres, more or less, and being in the Northeast Quarter of the Northwest Quarter of the Southwest Quarter of Section 14, Township 19 South, Range 2 West, Shelby County, Alabama.

2. That the sole general partner, Frank Haynie, and all of the limited partners, namely, Joe Mizerany, D. W. Huey, and J. C. Miller, wish to dissolve the said Limited Partnership. The real property has heretofore been conveyed and is no longer an asset of the partnership.

3. The outstanding indebtedness relating to the real property described above shall be assumed by the following individuals, Joe Mizerany, D. W. Huey, and J. C. Miller and such individuals do hereby release and indemnify the general partner, Frank Haynie,

from any liability thereunder.

4. THEREFORE, the said Haynie Ltd. is hereby expressly dissolved as provided for in Title 10 § 9-90 effective immediately.
