ARTICLES OF INCORPORATION

The undersigned, acting as incorporators, in order to form a corporation under and pursuant to the law of the State of Alabama, hereby adopt the following Articles of Incorporation:

1. NAME: The name of the corporation is:

3. PURPOSES: The purpose for which this corporation is organized are: The purpose for which this corporation is organized is to conduct all business activities of a bank holding company allowed by the laws of the United States and the transaction of any and all lawful business for which corporations may be incorporated under the Alabama Corporation Act.
4. AUTHORIZED SHARES: The aggregate number of shares of stock which the corporation shall have the authority to issue shall be 3 shares of common stock of the par value of \$100.00 per share.
