KNOW ALL MEN BY THESE PRESENTS, That whereas, on the 10 day of July, 1982, a notice was given of the intention to sell the lands hereinafter described and conveyed for the service charges to the North Shelby County Fire and Emergency Medical District then due from WALTER J. O'DAZIER and wife, RACHEL M. O'DAZIER, the owners of said land, and for the costs and expenses thereof and thereunder.

O'Dazier and wife, Rachel M. O'Dazier, owners as aforesaid of said land, and all the right, title, interest and claim of the North Shelby County Fire and Emergency Medical District on account of said charges in and to the following described lands hereinafter referred to, to-wit:

Lot 1, Block 1, Altadena Park Resurvey, as shown recorded in Map Book 5, Page 72 and 111, in the Probate Office of Shelby County, Alabama.
Situating in Shelby County, Alabama.

TO HAVE AND TO HOLD the same, the said rights, titles and interest unto the said North Shelby County Fire and Emergency Medical District and its heirs and assigns forever, but no right, title or interest of any reversioner or remainderman in said land is conveyed hereby.

This conveyance is subject to any and all rights of redemption held by said Walter J. O'Dazier and wife, Rachel M. O'Dazier.
