(3) That all known debts, obligations and liabilities of the said corporation have been paid and discharged or that adequate provisions have been made therefor:

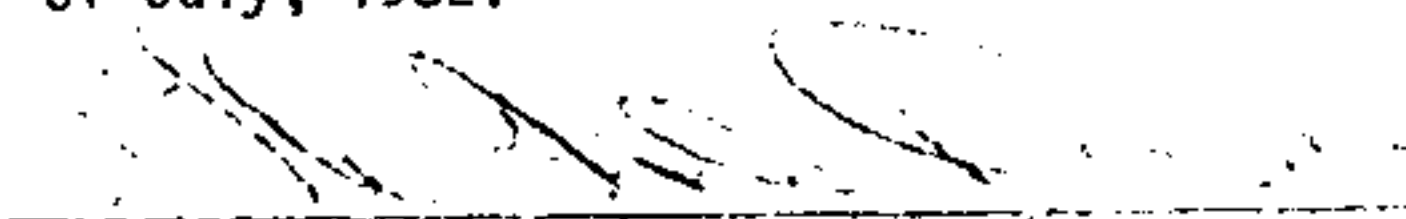
(4) That all the remaining property and assets of the said corporation have been distributed among its shareholders in accordance with their respective rights and interests;

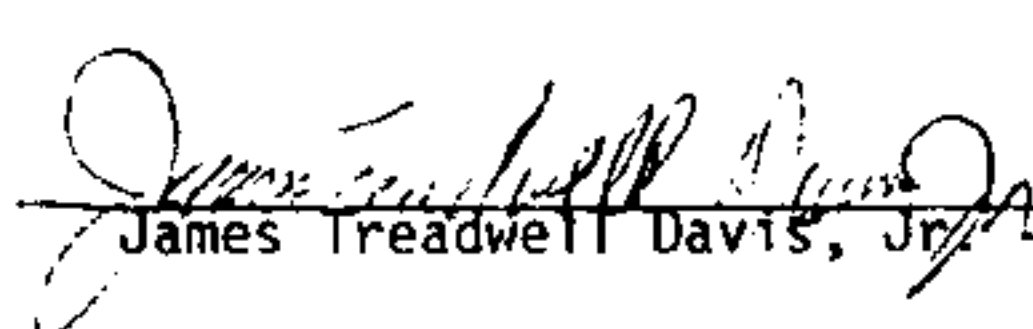

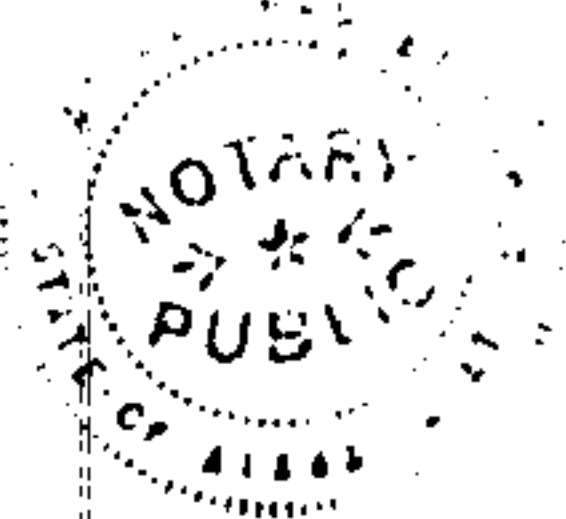
