WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, C. Ed. Castleberry and wife, Julie W. Castleberry, (hereinafter collectively referred to as the "Grantors"), are indebted to THE FIRST NATIONAL BANK OF BIRMINGHAM, a national banking association (the "Grantee"), as evidenced by certain promissory notes executed from time to time by one or some or all of the Grantors to the Grantee (the aforesaid indebtedness being hereinafter referred to as the "Indebtedness"), a portion of which Indebtedness is secured by that certain mortgage to the Grantee (the 'Mortgage") dated February 23, 1979, from the Grantors, as recorded in Mortgage Volume 413, page 22 in the office of the Judge of Probate of Shelby County, Alabama, which Mortgage covers that certain real property located in Shelby County, Alabama that is more particularly described in Exhibit A attached hereto and made a part hereof (the "Property"); and

WHEREAS, the fair market value of the Property is substantially less than the amount of the Indebtedness; and

WHEREAS, the Grantors have agreed to convey the Property to the Grantee and, in consideration of said conveyance and the performance by the Grantors of certain other requirements specified by the Grantee, the Grantee has performed certain other requirements specified by the Grantors and has agreed to accept said conveyance and said performance in partial satisfaction, among other things, of the Indebtedness.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, receipt of which the Grantors hereby acknowledge, and the aforesaid agreement of the Grantee with respect to the partial satisfaction of the Indebtedness, the Grantors do hereby grant, bargain, sell and convey unto The First National Bank of Birmingham, a national banking association, all of that certain real property situated in Jefferson County, Alabama that is more particularly described in Exhibit A attached hereto and made a part hereof, together with any and all rights of redemption, statutory or equitable, of the Grantors with respect thereto. The Grantors expressly make this conveyance without reservation or retention of any rights of redemption, statutory or equitable.

TO HAVE AND TO HOLD to The First National Bank of Birmingham, its successors and assigns, in fee simple forever.

The undersigned Grantors covenant with the Grantee that they are the owners of the Property and have a good right to sell and convey the same; that the same is free of all encumbrances; and that the Grantors will forever warrant and defend the title to the Property to the Grantee and to its successors and assigns. All covenants and agreements made herein shall bind the Grantors and their heirs, administrators and assigns.

It is understood and agreed that the lien and title of the Mortgage shall be merged in the title hereby conveyed only in the event of the full effectiveness of this conveyance according to the terms and provisions expressed herein, and that if for any reason this conveyance shall be held ineffective in any particular, or in the event of the setting aside of this conveyance in any proceedings instituted under the Bankruptcy Code or otherwise, the Grantee shall be subrogated to, or shall be considered to

have retained, all of its lien, title and rights under the Mortgage and any notes secured thereby, and in any such event the Grantee shall have the right to proceed to a foreclosure of the Mortgage in all respects as if this instrument had not been executed.
