VANDEGRIFT, Clerk of the United States District Court for the Northern District of Alabama, do hereby certify that on the sixth day of July, 1982, a summary judgment was rendered by said Court in the above-styled cause wherein E. F. HUTTON CREDIT CORPORATION obtained a summary judgment against MINERAL LAND AND MINING CONSULTANTS, INC.; CHARLES J. SMITH and CHARLES ROSS SMITH whose addresses are: (1) Mineral Land and Mining Consultants, Inc. - 1500 21st Avenue, Haleyville, Alabama 35565; (2) Charles J. Smith - Route Two, Box 35, Leeds, Alabama 35094; (3) Charles Ross Smith - 610 Cedar Street, Hartselle, Alabama, as shown in the Court proceeding for the sum of (1) ONE HUNDRED FORTY EIGHT THOUSAND NINE HUNDRED THIRTY SEVEN AND 50/100 (\$148,937.50) DOLLARS; (2) interest on the amount specified in (1) at the rate of SIX PERCENT (6%) per annum from May 19, 1981, to this date, or TEN THOUSAND ONE HUNDRED ELEVEN AND 43/100 (\$10,111.43) DOLLARS; (3) EIGHT THOUSAND THREE HUNDRED FOUR AND 43/100 (\$8,304.43) DOLLARS; (4) interest on the amount specified in (3) at the rate of 14.5% per annum from May 19, 1981, to this date, or ONE THOUSAND THREE HUNDRED SIXTY TWO AND 50/100 (\$1,362.50) DOLLARS; and (5) attorney's fees in the amount of TWENTY PERCENT (20%) of ONE HUNDRED FIFTY SEVEN THOUSAND TWO HUNDRED FORTY ONE AND 93/100 (\$157,241.93) DOLLARS, or THIRTY ONE THOUSAND FOUR HUNDRED FORTY EIGHT AND 39/100 (\$31,448.39) DOLLARS, for a total judgment of TWO HUNDRED THOUSAND ONE HUNDRED SIXTY FOUR AND 25/100 (\$200,164.24) DOLLARS, together with the costs of Court incurred herein by plaintiff; it was further ORDERED by the Court that payment of the proceeds of this judgment and costs herein be made directly to the attorneys of record for the plaintiff, and upon receipt thereof, such attorneys will satisfy said judgment on the records of this Court; and that Harvey L.
