## ALABAMA HOUSING FINANCE AUTHORITY UNLIFORM MORTGAGE RIDER

The rights and obligations of the parties to the Mortgage to which this Rider is attached and the Note which it secures are expressly made subject to this Rider. In the event of any conflict between the provisions of this Rider and the provisions of the Mortgage or Note, the provisions of this Rider shall control. To the extent they are not modified by this Rider, all the terms, conditions and other provisions of the Mortgage and Note remain in full force and effect.

- 1. The Borrower agrees that the Lender, the Alabama Housing Finance Authority (the "Authority") or their assigns may, at any time and without prior notice, accelerate all payments due under the Mortgage and Note and exercise any other remedy allowed by law or provided by the Mortgage for breach of the Mortgage or Note if:
  - (a) All or any part of the Property or any interest therein is sold or transferred by Borrower or by operation of law, excluding (i) the creation of a lien or encumbrance subordinate to this Mortgage under a UDAG loan permitted under the Authority's Program Guidelines, 1981 Series A, (ii) the creation of a purchase money security interest for household appliances, or (ii1) a transfer by operation of law upon the death of a joint tenant.
- (b) The Borrower fails to abide by any agreements made with the Authority, or the Lender, or if the Lender or the Authority finds any statement contained in the Affidavit of Eligibility of the Borrower or any other document executed by the Borrower to be untrue, inaccurate or incomplete.
- (c) The Borrower fails to promptly supply any information or document which the Lender, or the Authority may request to verify compliance with the conditions of the Authority's Single Family Mortgage Program under which the Loan as evidenced by the Mortgage was provided.

The Borrower understands that the Authority and the Lender have relied upon statements contained in the Affidavit of Eligibility of the Borrower and all other documents submitted in support of the Loan Application in the processing, financing and granting of this Loan. Upon discovery of fraud or misrepresentation by the Borrower with respect to any information provided by the Borrower in the Loan Application or Borrower's Affidavit of Eligibility executed in connection with the Note, the Lender or the Authority may, in their sole discretion, by written notice to Borrower, declare all obligations secured by the Mortgage and all obligations payable under the Note immediately due and payable. Borrower shall notify the Lender and the Authority promptly in writing of any transaction or event which may give rise to a right of acceleration hereunder. The Borrower must make monthly payments regardless of credits until the payments and credits completely amortize the Borrower's debt.
- (b) In the event the credit is made at the time the Mortgage is discharged, a determination as to the amount of credit will be made as of the annual determination date established by the Authority which precedes the date of discharge. Creditwill not be made with respect to any partial annual period the Mortgage is outstanding following such annual determination date. To the extent necessary, any balance of the credit, remaining after the principal of the Note has been fully paid, will be applied against interest payments due on the Note. Notice will also be given to the Borrower if at any time the amount of the credit due the Borrower equals or exceeds the principal balance of the Note, and final settlement will be made accordingly.
