

ARTICLES OF INCORPORATION
OF
BILL PHARES MINISTRIES, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Laws of the State of Alabama, and we hereby certify as follows:

ARTICLE I

The name of this corporation is Bill Phares Ministries, Inc.

ARTICLE II

The duration of this corporation is perpetual.

ARTICLE III

The purposes for which this corporation is formed are as follows:

1. To propagate the Gospel of Christ in the following manner:

John 8:31-32: Then said Jesus to those Jews which believed on him, "If ye continue in my work, you are my disciples indeed; and ye shall know the TRUTH, and the TRUTH shall make you free."

A. The Gospel shall be propagated through the use of broadcast media, literature, and evangelical crusades.

B. The Gospel shall be propagated through the establishment of local bodies, prayer groups, and associations of believers, which may form themselves into New Testament churches.

C. The Gospel shall be propagated by licensing ordained Christian workers, ministers, and missionaries, and by planting and establishing branches, missions, and other types of fellowships.

2. This corporation is organized exclusively for the purposes set forth in IRC §501 (c) (3). In addition, the corporation's assets are hereby dedicated to be distributed on dissolution of the corporation exclusively to organizations which are also organized exclusively for the purposes set forth in IRC §501 (c) (3). In addition, the corporation's assets are to be sold and distributed upon dissolution by the existing board of

ARTICLE IV

ARTICLE V

ARTICLE VI

The classification of, privileges of, qualifications, form and matter of application for discipline and removal of members shall be regulated by the By-Laws duly adopted.

The membership of Bill Phares Ministries, Inc. shall be composed of those who have been born again and seek faithfully to follow the Lordship of Christ in accordance to the scriptural teachings set forth in the Bible.

ARTICLE VII

This corporation reserves the right to amend, alter, change, or repair any provisions contained in these Articles of Incorporation and in a manner now, or hereafter prescribed by statute. This change must take place by majority vote of the board of directors. All rights conferred upon members herein granted are subject to these reservations.
