From the purpose of further securing the payment of the indebtedness, the Mortgagor agrees to pay all taxes of assessments when imposed legally upon the real estate, and should default be made in the payment of same, the Mortgagoe may at Mortgagoe's option pay off the same; and to further secure the indebtedness, Mortgagor agrees to keep the improvements on the real estate insured against loss or damage by fire, lightning and tornado for the fair and reasonable insurable value thereof, in companies satisfactory to the Mortgagoe, with loss, if any, payable to Mortgagoe as its interest may appear, and to promptly deliver said policies, or any renewal of said policies to Mortgagoe; and if undersigned fails to keep property insured as above specified, or fails to deliver said insurance policies to Mortgagoe, then Mortgagoe, or assigns, may at Mortgagoe's option insure the real estate for said sum, for Mortgagoe's own benefit, the policy if collected to be credited on the indebtedness, less cost of collecting same. All amounts so expended by Mortgagoe for taxes, assessments or insurance, shall become a debt to Mortgagoe or assigns, additional to the debt hereby specially secured, and shall be covered by this Mortgagoe, and bear interest at the same interest rate as the indebtedness secured hereby from date of payment by Mortgagoe or assigns and be at once due and payable.
