

ARTICLES OF DISSOLUTION

PURSUANT TO SECTION 10-2A-190 OF THE CODE OF ALABAMA

Pursuant to the provisions of Section 10-2A-190 of the Code of Alabama, the undersigned corporation, Dixie Alloy Manufacturing Corporation, does hereby adopt the following Articles of Dissolution for the purpose of dissolving the Corporation:

FIRST: The name of the Corporation is Dixie Alloy Manufacturing Corporation.

SECOND: A statement of intent to dissolve the Corporation was filed with the Judge of Probate of Shelby County, Alabama, on the 5th day of November, 1982, pursuant to the provisions of Section 10-2A-183 of the Code of Alabama.

THIRD: All debts, obligations and liabilities of the Corporation have been paid and discharged, or adequate provisions have been made therefor.

FOURTH: All remaining property and assets of the Corporation have been distributed among its shareholders, in accordance with their respective rights and interests.

FIFTH: There are no suits pending against the Corporation in any Court in respect of which adequate provision has not been made for the satisfaction of any judgment, order or decree which may be entered against it.

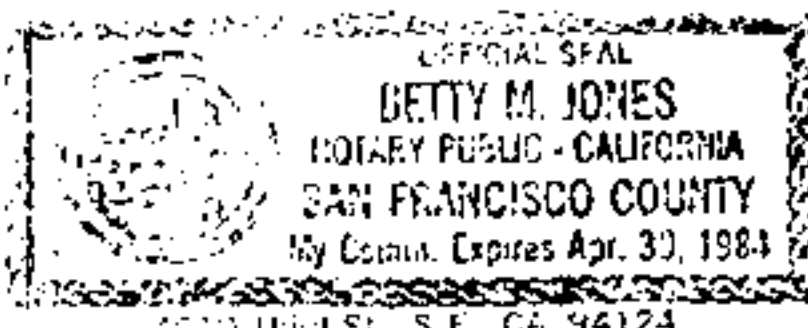
