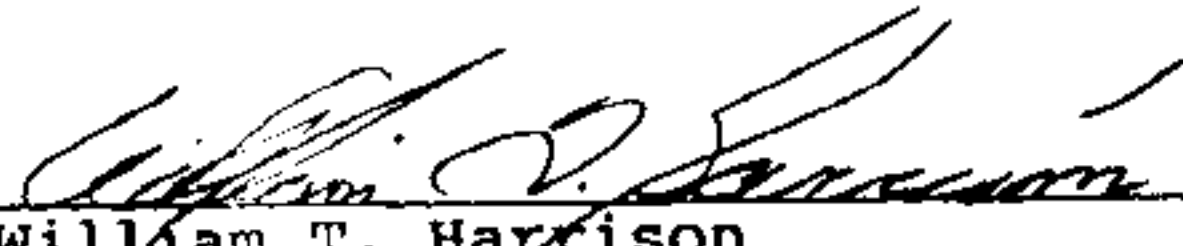

A temporary easement to a strip of land necessary for construction and being more fully described as follows: Beginning at a point on the south line of the SW 1/4 of SW 1/4, Section 30, T-19-S, R-2-W that is 20 feet easterly of and at right angles to the present east right-of-way line of U. S. Highway No. 31; thence westerly along the south line of said SW 1/4 of SW 1/4 a distance of 20 feet, more or less, to the present east right-of-way line of said highway; thence northerly along said present east right-of-way line a distance of 85 feet, more or less, to a flare connecting said present east right-of-way line with the present southeast right-of-way line of Shelby County Road No. 17; thence turn an angle of 90 deg. to the right and run a distance of 20 feet; thence turn an angle of 90 deg. to the right and run a distance of 83 feet, more or less, to the point of beginning.
