ARTICLES OF INCORPORATION
OF
RS CHEMICAL, INC.

The undersigned, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is RS Chemical, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To purchase, sell, manufacture, broker and trade in chemicals and related products and to undertake all activities connected therewith as well as any and every other activity authorized a corporation by the Code of Alabama.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000) shares of one class of stock only, at no par value.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are: The President may hold every other office simultaneously and shall be authorized to sign all documents and undertake other activities without attestation.

SIXTH: The address of the initial registered office of the corporation is 1478 Sequoia Trail, Alabaster, Alabama 35007, and the name of its initial registered agent at such address is Ronald W. Smith.
