"CORRECTIVE DEED"

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of TWELVE THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$12,500.00) in hand paid by M.E. PADGETT D/B/A M.E. PADGETT CONSTRUCTION CO.
