I further authorize any of said named persons as may qualify hereunder all necessary and proper conveyance transfers, assignments or bills of sale as might be required or become convenient in order to vest good, indefeasible title in the purchaser to whom they may sell, any part of my property. My Executrix shall be the sole judge of the price and terms of the sale and discretion of either when so exercised shall not be subject to review of any court or courts whatsoever.
