(A) Generally

I will obtain hazard insurance to cover all buildings and other improvements that now are or in the future will be located on the Property. The insurance must cover loss or damage caused by fire, hazards normally covered by "extended coverage" hazard insurance policies, and other hazards for which Lender requires coverage. The amount paid by the insurance company is called "proceeds." The proceeds will be used to reduce the amount that I owe to Lender under the Note and this Mortgage, unless Lender and I have agreed to use the proceeds for repairs, restoration or otherwise.

The Lender has the authority to settle any claim for insurance benefits and to collect the proceeds. Lender then may use the proceeds to reduce the amount that I owe to Lender under the Note and under this Mortgage or to repair or restore the Property as Lender may see fit.

If any proceeds are used to reduce the amount of principal which. I owe to Lender under the Note, that use will not delay the due date or change the amount of any of my monthly payments under the Note and this Mortgage. However, Lender and I may agree in writing to those delays or changes.

If Lender acquires the Property by purchase at foreclosure sale, all of my rights in the insurance policies will belong to Lender. Also, all of my rights in any proceeds which are paid because of damage that occurred before the Property is acquired by Lender will belong to Lender. (B) Agreements that Apply to Condominiums

(A) Interest Rate Adjustments

The Note provides for an adjustable interest rate which will be increased or decreased on the Interest Adjustment Dates as described in the Note. Changes in the interest rate are determined by changes in the Index Rate. The Index Rate is the auction rate for United States Treasury Bills with maturities of 26 weeks, as established at the most recent auction immediately prior to the date of the Note and each subsequent Interest Adjustment Date. There are no limitations on changes in the interest rate, except that the interest rate may be subject to a ceiling or floor rate.

(B) Monthly Payment Adjustments

If the rate of interest changes, the amount of my payment will change as provided in the Note.
