The southwest quarter of the northwest quarter (SW-1/4 of NW-1/4) of Section 11 and the northeast quarter of the northeast quarter (NE-1/4 of NE-1/4) of Section 9, all in Township 22 South, Range 4 West, containing 80 acres, more or less.

Less and except, however, all the oil, gas, coal, iron ore, limestone, sulphur and all other minerals in, under or upon said lands, together with the right to mine and remove the same, and the rents and royalties therefor, and that certain Oil and Gas Lease dated as of August 1, 1981, between Champion International Corporation and The Louisiana Land and Exploration Company.

The above-described land is subject to easements and rights of way of record or in use and the lien for ad valorem taxes for the current tax year.
