thence turn an angle of 37 deg. 43 min. 39 sec. to the left and run along said gravel road a distance of 210.47 feet; thence turn an angle of 16 deg. 49 min. 27 sec. to the right and continue along said gravel road a distance of 324.75 feet; then turn an angle of 93 deg. 48 min. to the left and run a distance of 300.00 feet; thence turn an angle of 75 deg. 27 min. 06 sec. to the left and run a distance of 665.12 feet; thence turn an angle of 78 deg. 53 min. 28 sec. to the left and run a distance of 400.00 feet to the East line of the NE 1/4 of the SW 1/4, Section 22; thence turn an angle of 90 deg. 57 min. 18 sec. to the left and run North along said East line a distance of 220.35 feet to the point of beginning. Situated in the NE 1/4 of the SW 1/4, and the S 1/2 of the SE 1/4 of the NW 1/4 of Section 22, Township 21 South, Range 1 East, Huntsville Meridian, Shelby County, Alabama.
