

A parcel of land located in the Southeast One-Quarter of the Northeast One Quarter of Section 14, Township 20 South, Range 3 West, Shelby County, Alabama being more particularly described as follows: Commence at the Northeast corner of said Quarter-Quarter Section; thence 52 degrees, 02 minutes right measured from the East line of said Quarter-Quarter Section in a Southwesterly direction for a distance of 413.34 feet; thence 39 degrees, 15 minutes, 25 seconds left and run in a Southwesterly direction for a distance of 104.09 feet; thence turn an angle to the right of 73 degrees, 52 minutes, 41 seconds and run in a Southwesterly direction for a distance of 401.10 feet; thence turn an angle to the left of 73 degrees, 34 minutes, 46 seconds and run in a Southwesterly direction for a distance of 88.66 feet to the point of beginning. From the point of beginning thus obtained, thence continue along last described course for a distance of 90.47 feet; thence turn an angle to the left of 88 degrees, 50 minutes and run in a Southeasterly direction for a distance of 0.51 feet to the point of beginning of a curve to the right; said curve having a central angle of 2 degrees, 33 minutes, 55 seconds and a radius of 659.31 feet; thence run along the arc of said curve to the right in a Southeasterly direction for a distance of 29.52 feet; thence turn an angle to the left from the tangent of the last described course of 93 degrees, 43 minutes, 55 seconds and run in a Northeasterly direction for a distance of 91.74 feet; thence turn an angle to the left of 90 degrees and run in a Northwesterly direction for a distance of 30 feet to the point of beginning.
