I

II.

The period of duration of the corporation is perpetual.

III.

The general purposes of the Club are as follows:

- B. To promote fellowship among owners of Corvette automobiles;
- C. To encourage and provide planned trips, events and social activities for members of the Club, including, but not limited to, car shows, sport car rallies, field trips and the like.

IV.

There shall be four classes of members of the corporation, consisting of New members, Honorary members, Active members and Associate members.

The affairs of the corporation shall be managed by a board of directors of four members, consisting of the president, the vice-president, the secretary and the

Notwithstanding any of the powers or purposes of the corporation contained in this exertificate of incorporation or granted by law, this corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, mor shall it engage in any activity of any kind whatever involving the carrying on oppopaganda, nor shall it attempt in any manner to influence legislation, nor shall it engage in any activities which are not in themselves tax-exempt under the Internal Revenue Code of the United States of America.

#### VIII.

No funds or assets of the corporation shall at any time enure to the benefit of any person except charitable recipients. No charitable recepient may be related within the fourth degree of consanguinity or the third degree of affinity to any member of the Mid Alabama Corvette Club. If the corporation is ever dissolved, its assets shall be distributed only to another tax-exempt organization, or to the government of the United States of America, the state of Alabama, or the County of Shelby, Alabama, and moreover, said assets may only be used for a public purpose.
