CERTIFICATE OF INCORPORATION

The undersigned, desiring to organize a body corporate under the laws of the State of Alabama, Code of Alabama Section 10-4-20, being the Trustees of the First United Methodist Church of Pelham, do hereby make, sign and file this Certificate of Incorporation as follows:

1. The name of the corporation is First United Methodist Church of Pelham, Inc., and the corporation shall be authorized to function in said name.


2. The function of said corporation shall be to acquire, hold, administer, distribute or dispose of real and personal property, take, receive and acquire property by gift, devise, or bequest, and to hold, own, administer, use, distribute and dispose of such property for the advancement, promotion, extension or maintenance of the Church body.


3. The names of the Trustees and the length of time for which they are elected is:




