

3. In the event of the sale of the property described in Paragraph 2 hereof, plaintiff will cause defendant to be paid any portion of said judgment remaining unpaid at said time, and any accrued interest thereon, from the proceeds of sale. Plaintiff's obligation to pay said judgment, however, is absolute, and is not affected by whether said property shall be sold, or by the adequacy of the proceeds of sale to pay the balance of said judgment and interest.


4. The provisions of Paragraph 5 of the Agreement incorporated into the original judgment of divorce in this cause shall be and remain in full force and effect.

7. Costs of court herein are taxed against the plaintiff.


