

CERTIFICATE OF INCORPORATION
OF
SHELBY COUNTY AIRPORT AUTHORITY

TO THE HONORABLE THOMAS A. SNOWDEN, JR., JUDGE OF PROBATE
IN AND FOR SHELBY COUNTY, ALABAMA

The undersigned, Larry Lynn Miller, Douglas H. Ballard, G. Alvon Dampier, Richard Simpson and Robert W. Tucker, Jr., each of whom is over the age of nineteen years and each of whom is a qualified elector of and property owner in Shelby County, Alabama, desiring and having been authorized by the governing body of said county to organize a body corporate under the laws of the State of Alabama and particularly under Act No. 331 adopted at the 1977 session of the Legislature of Alabama, and being all of the incorporators of the corporation hereby organized, do make, sign and file this certificate of incorporation.

(1) The name of the corporation is and shall be: SHELBY COUNTY AIRPORT AUTHORITY.

(2) The names and residence of each of the persons forming the Shelby County Airport Authority are as follows: Larry Lynn Miller, 1234 Lake Forest Cir., Birmingham, Alabama 35244, Douglas H. Ballard, Route 1, Box 29, Montevallo, Alabama 35115, G. Alvon Dampier, 916 Riverchase Parkway West, Birmingham, Alabama, 35244, Richard Simpson, 2436 Chuchura Dr., Birmingham, Alabama 35244, Robert W. Tucker, Jr., Route 1, Box 114, Montevallo, Alabama 35115.

(3) The duration of the existence of the corporation shall be perpetual.

(4) The authorizing governing body authorizing the incorporation of this Authority is the Shelby County Commission which authorized the incorporation of said Authority by resolution dated the 9 day of MAY, 1983.

(5) The proposed location of the principal office of said Authority shall be: Shelby County Airport Authority, 504 Highway 70, Columbiana, Alabama 35051.

(6) Said Shelby County Airport Authority shall have all powers and authority as are authorized by said Act No. 331 referred to above.

(7) The Shelby County Airport Authority shall be governed by a board of directors consisting of five members, all to be elected by the Shelby County Commission in accord with the provisions of Act No. 331. The directors initially elected shall be elected for terms of office of two, four and six years, respectively, and their successors shall be elected for a term of six years. Any member of the Shelby County Commission shall be eligible for election to the board of directors. The Judge of Probate of Shelby County shall ex-officio be entitled to notice of each special or call meetings and have the right to attend all meetings of the board but shall have no right to vote at any such meetings and shall not be considered in determining a quorum.

(8) The corporation shall be a nonprofit corporation, and no part of the net earnings thereof, if any, shall inure to any

member thereof or to any other individual or private corporation.

(9) There is attached hereto a certified copy of the resolution of the Shelby County Commission authorizing the corporation hereof and also attached hereto a certificate from the Secretary of State that the name proposed for this authority is not identical to that of any other corporation organized under the laws of the State of Alabama or so nearly similar thereto as to lead to confusion and uncertainty.
