- (2) That defendants will satisfy this judgment by making twenty-six

  (26) monthly payments of FIFTY AND 00/100 (\$50.00) DOLLARS each

  commencing June 5, 1983 and a final payment of TWENTY ONE AND 48/100

  (\$21.48) DOLLARS. The monthly payments are due on or before the fifth day of each month.
- (3) That in the event any monthly installment as specified in paragraph
  2 above is in default ten days or more, a late charge of five percent
  of the amount of such scheduled payment shall be added to the outstand-

ing balance. If the default is not cured within twenty days, the Plaintiff shall have the following options:

- to accelerate the total remaining outstanding (1) balance and to declare said balance immediately due and payable, with interest at the rate of eighteen percent per annum on the unpaid balance together with costs and reasonable attorneys fee,  $\mathbf{or}$
- to add one and one-half percent interest per month (2) on the outstanding unpaid balance.
- (4) That payment of the proceeds of this judgment shall be made directly to the attorneys of record for the Plaintiff and that, upon receipt thereof, such attorneys will satisfy this judgment on the records of this Court; and that Frank W. Donaldson, United States Attorney for the Northern District of Alabama, is the attorney for the UNITED STATES OF (AMERICA in said cause.
