By consent, judgment rendered in favor of plaintiff and against defendants for the sum of Twelve Thousand Five Hundred and no/100 Dollars (\$12,500.00) and all court costs taxed against defendants; however, execution is stayed pending the payment of the sum of Seven Thousand Five Hundred and no/100 Dollars (\$7,500.00) in installments of One Thousand Dollars (\$1,000.00) each ninety (90) days with the first installment payable on June 15, 1983, and \$1,000.00 each 90 days thereafter until the sum of \$7,500.00 and all court costs are paid; upon the payment in full of \$7,500.00 the plaintiff will mark the judgment paid and satisfied in full; and further provided that should defendants fail to make all of the said payments due hereunder they, nevertheless, shall have credit for any amounts paid against the full sum of \$12,500.00 which stands subject to execution.
