

LAST WILL AND TESTAMENT

KNOW ALL MEN BY THESE PRESENTS:

That I, Nallie Ruth Armstrong, a resident of Jefferson County, Alabama being of sound mind and disposing memory, do hereby make and declare this to be my Last Will and Testament, hereby revoking any and all Wills heretofore made by me at any time.

1. It is my will that my Executor hereinafter named pay my just debts, the expense of my last illness and my funeral expenses as soon after my decease as seems convenient.

2. I hereby give, will and bequeath unto my three children, my daughter Ruth A. Comer, and my sons James Elwood Armstrong, Jr. and Roy Mack Armstrong, all of my property of every kind and discription, both real, personal or mixed of which I shall die seized or possessed or to which I shall be entitled at my decease for the period of their natural lives. It is my intention they each shall share alike and equally in the distribution of my estate. Should either of my children die their share shall be divided among that child's children. With the exception of the farm land in Shelby County which I wish to go to my daughter Ruth A. Comer and her three children, Ruth Ann Comer, Helen Ina Comer and Ralph Thomas Comer, Jr.

3. I do hereby nominate and appoint my son James Elwood Armstrong, Jr. as my Executor of this my Last Will and Testament and it is my wish that he be exempt from making an Official Bond or from making any report to any Court, of his acts as such Executor.
