LOAN MODIFICATION AGREEMENT

THIS AGREEMENT made and entered into on this 8th day of August, 19 83, by and between FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF BESSEMER, BESSEMER, ALABAMA, (herein called ASSOCIATION), and D. W. WHITLOCK and W. E. WHITLOCK, (herein called BORROWER, whether one or more);

W I T N E S S E T H:

WHEREAS, Borrower is indebted to Association as evidenced by promissory note dated September 3rd, 1981, secured by mortgage of same date conveying certain real property in Shelby County, Alabama, said mortgage being of record in ~~Real~~ Volume 415, page 241, in the Office of the Judge of Probate of Shelby County, Alabama, (~~Bessemer Division~~); and

WHEREAS, Association and Borrower mutually desire to revise and modify the terms of payment of said indebtedness;

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

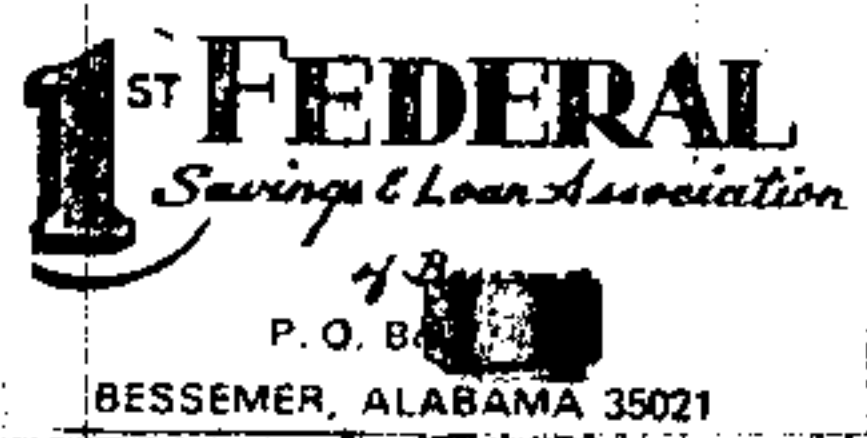

The unpaid balance of said indebtedness is now THIRTEEN THOUSAND FOUR HUNDRED NINETY-EIGHT AND 22/100----- DOLLARS, (\$ 13,498.22 ), and Borrower has this date executed a new promissory note evidencing such indebtedness, and amending and revising the amount and dates of payments and rate of interest to be paid by Borrower on such indebtedness.

2. No additional funds have been advanced by Association to Borrower, and, except as modified by this agreement and by the note of this date which now evidences said indebtedness, all other terms and conditions of the aforesaid mortgage shall remain in full force and effect and this agreement shall in no wise and to no extent whatever affect, impair or destroy the lien of said mortgage.
