ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE CAREFREE CLINIC, INC.

Pursuant to the provisions of Section 10-3-40 et seq. of the Alabama Code of 1975, as amended, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is The Carefree Clinic, Inc.

SECOND: The following amendments to the Articles of Incorporation were adopted in the manner prescribed by the Alabama Non-Profit Corporation Act:

- "The first article of incorporation is hereby amended so as to change the name of the corporation to THE CAREFREE MANOR, INC."
- 2. "The sixth article of incorporation is hereby amended by substituting the following:

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or local government for exclusive public purpose.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under Sections 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law or (b) a corporation, contributions to which are

deductible under Section 170(c) (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue law.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law).

3. The eighth article of incorporation is hereby amended so that the number of directors constituting the initial Board of Directors is sixteen (16) and the name, address and occupation of the persons who are to serve as the initial directors are:
